From the take-over of the Kien Hung activities, we build the Hamburg Süd set up in Asia to an organization which counted 300 staff with 8 own offices in Hong Kong, China, Singapore and Taiwan.

I was responsible for the bottom line result of the Asian services as well as the commercial activities in the Asian region, We expanded the HSDG business from roughly 1000 teu export per week in 3 trades to roughly 8000 teu per week in 5 trades and managed to position Hamburg Süd as a renowned quality carrier with a market share of between 10 and 15 % in the main North – South trades.

2001 - 2003 Managing Director Region Oceania and Asia Hamburg Süd Australia

Based in Sydney, I was responsible for the commercial activities of Hamburg Süd in Australia, New Zealand and the Pacific Islands.

In view of the fact that our activity in Asia was still very limited (some 500 teu per week) the Asian activities were likewise controlled from the Sydney office.

During my tenure we entered the trades between Australia / New Zealand and North and South East Asia.

Based in Santiago, I was responsible for the Hamburg Süd activities in the West Coast of South America.

Inheriting a poorly functioning agency set up (Furness Withy), we build a solid organization with own offices in Chile, Peru and Ecuador and a dedicated agency set up in Colombia and Bolivia,

From a single trade lane (North Europe –WCSA) we opened new services to the US West Coast, Asia and to the US East Coast.
